Arizona Employment Increased by 66,200 Jobs since June 2023 Arizona Unemployment Decreased to 3.3%, a Record Low for Arizona*

The Arizona seasonally adjusted (SA) unemployment rate decreased to 3.3% in June 2024 from 3.4% in May 2024. The U.S. SA unemployment rate increased to 4.1% in June 2024 from 4.0% in May 2024.

Month over month, Arizona's SA labor force increased by 6,837 individuals, or 0.2%. Year over year, the SA labor force increased by 58,397 individuals, or 1.6%.

Month over month, Arizona not-seasonally adjusted (NSA) total nonfarm employment decreased by 46,300 jobs. Year over year, NSA total nonfarm employment increased by 66,200 jobs, or 2.1%. Arizona SA total nonfarm employment decreased by 1,900 individuals, or 0.1%, month over month.

Month Over Month

Arizona NSA nonfarm employment decreased by 46,300 jobs in June. Prior to the pandemic (2010-2019), NSA nonfarm employment lost 51,600 jobs on average in June. The private sector recorded a loss of 12,300 jobs in June, led by losses in Professional & Business Services (-5,000 jobs) and Private Educational Services (-4,600). Prior to the pandemic (2010-2019), private sector employment averaged a loss of 8,900 jobs in June. The government sector¹ recorded a loss of 34,000 jobs in June, less than the pre-pandemic (2010-2019) average loss of 42,700 jobs. Employment losses in the government sector occurred primarily within Local Government Education (-24,400 jobs).

- Financial Activities (2,400 jobs)
- Construction (400 jobs)
- Manufacturing (200 jobs)
- Natural Resources & Mining (100 jobs)
- Information (100 jobs)

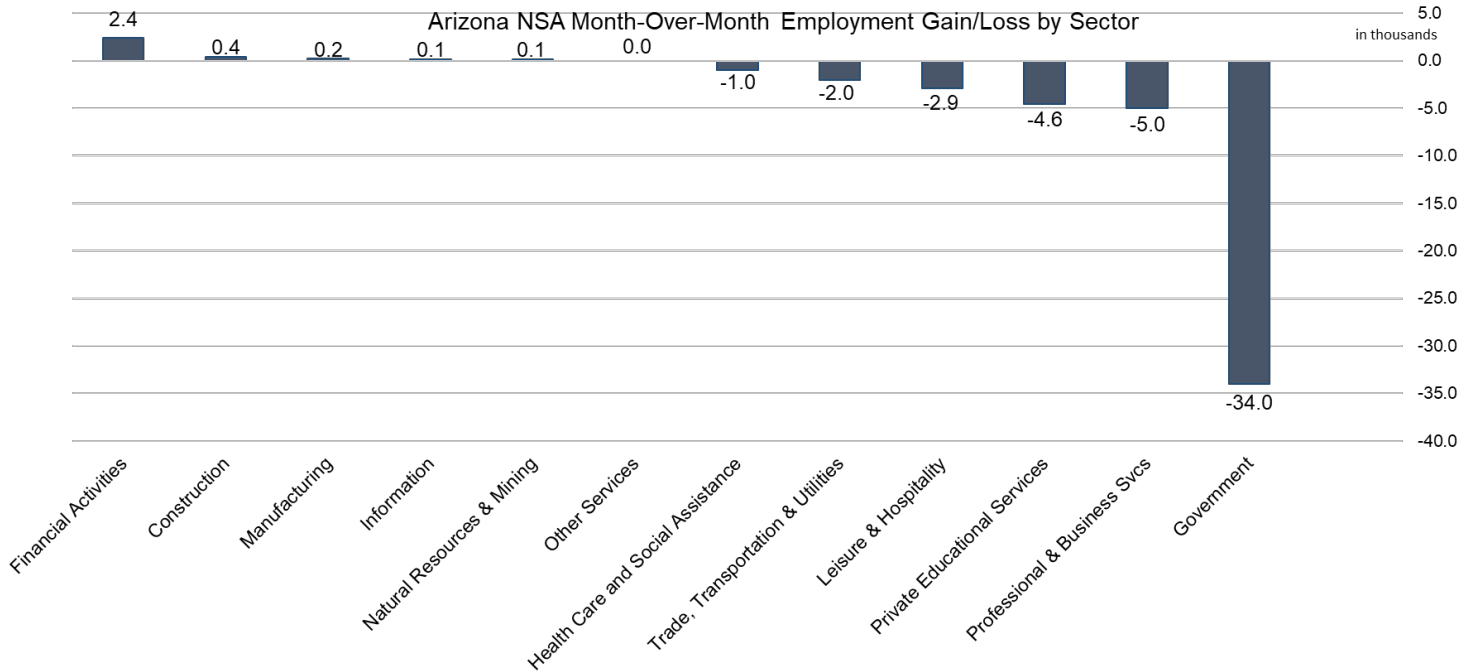

Year Over Year

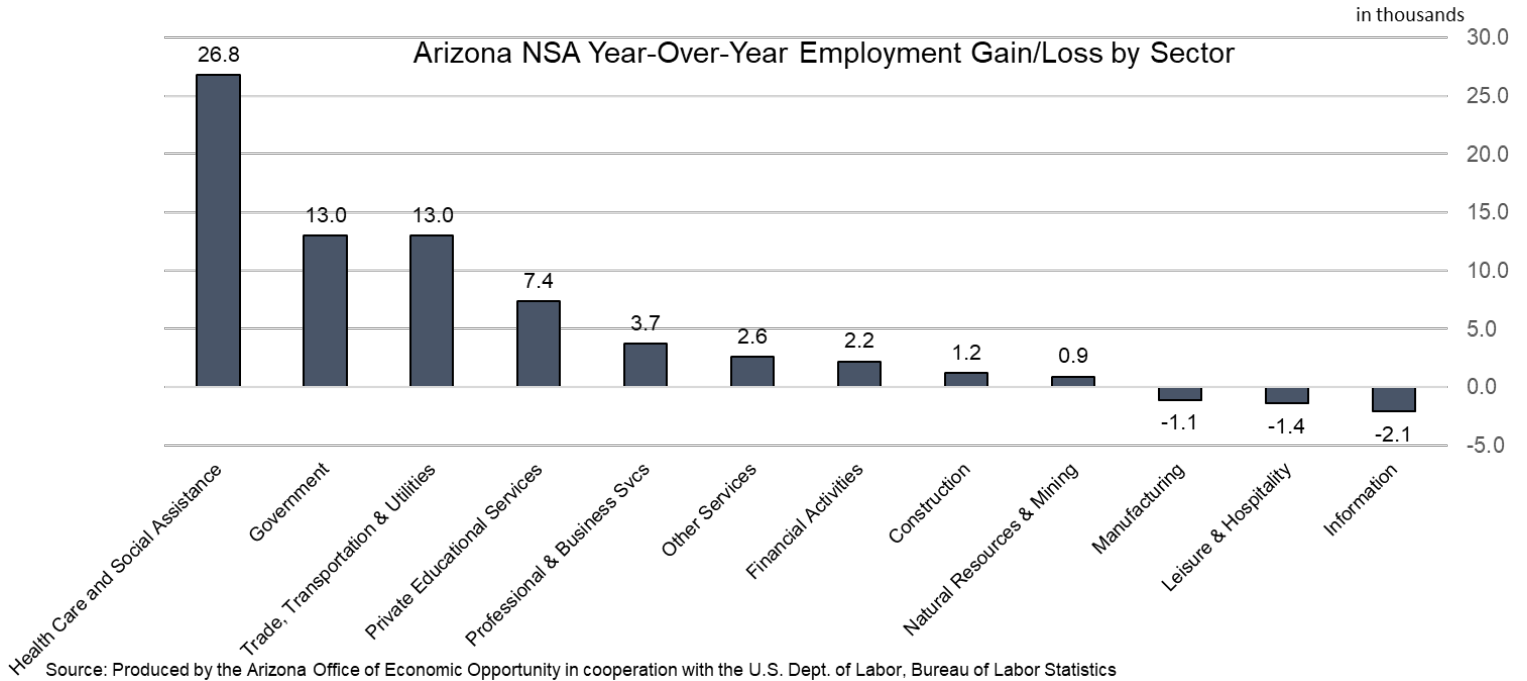
Arizona NSA nonfarm employment increased by 66,200 jobs or 2.1% in June year over year. Private sector employment increased by 53,200 jobs year over year, while government employment increased by 13,000 jobs year over year.

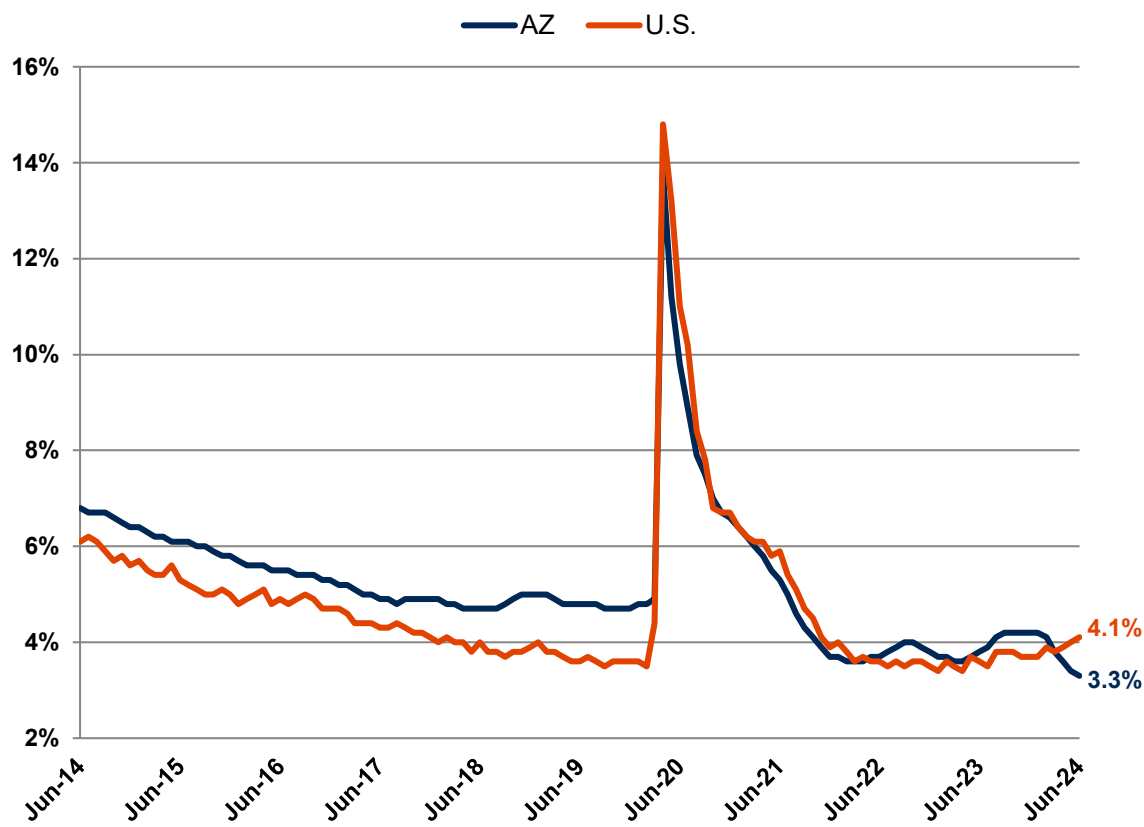

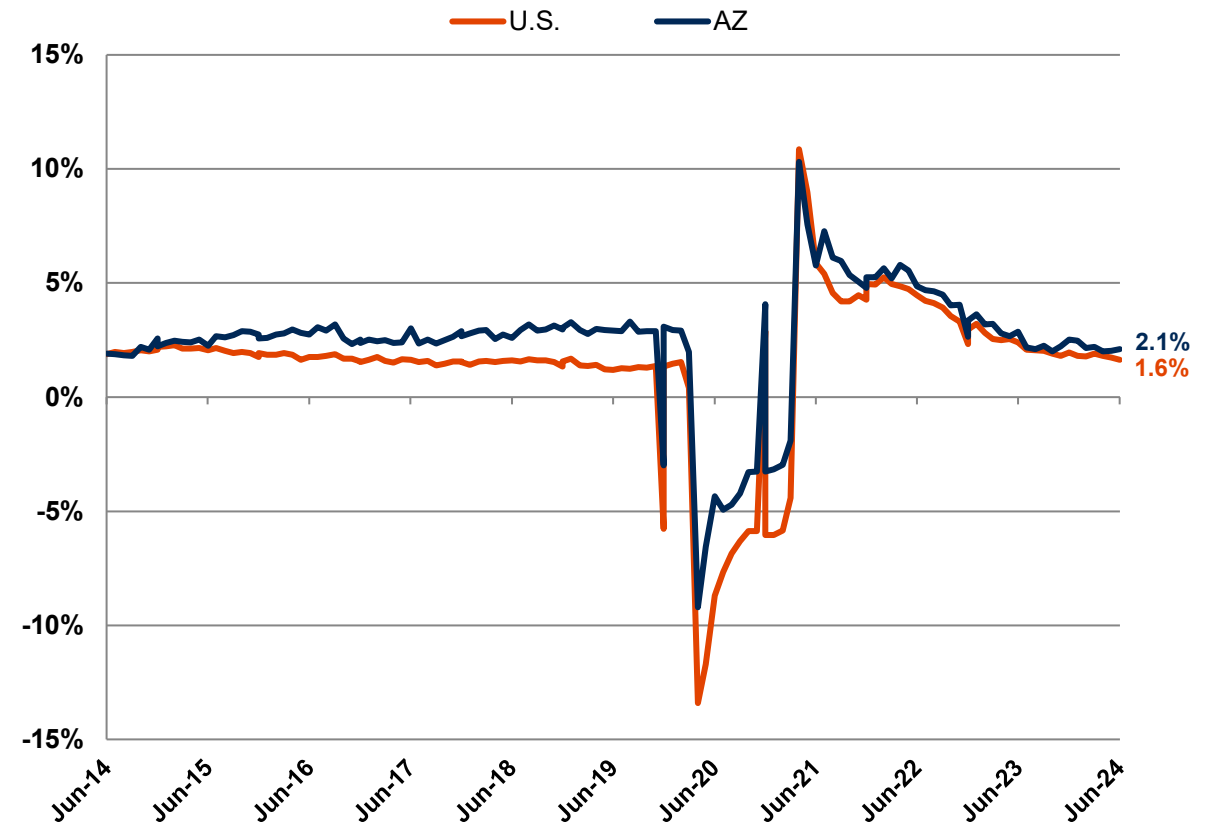

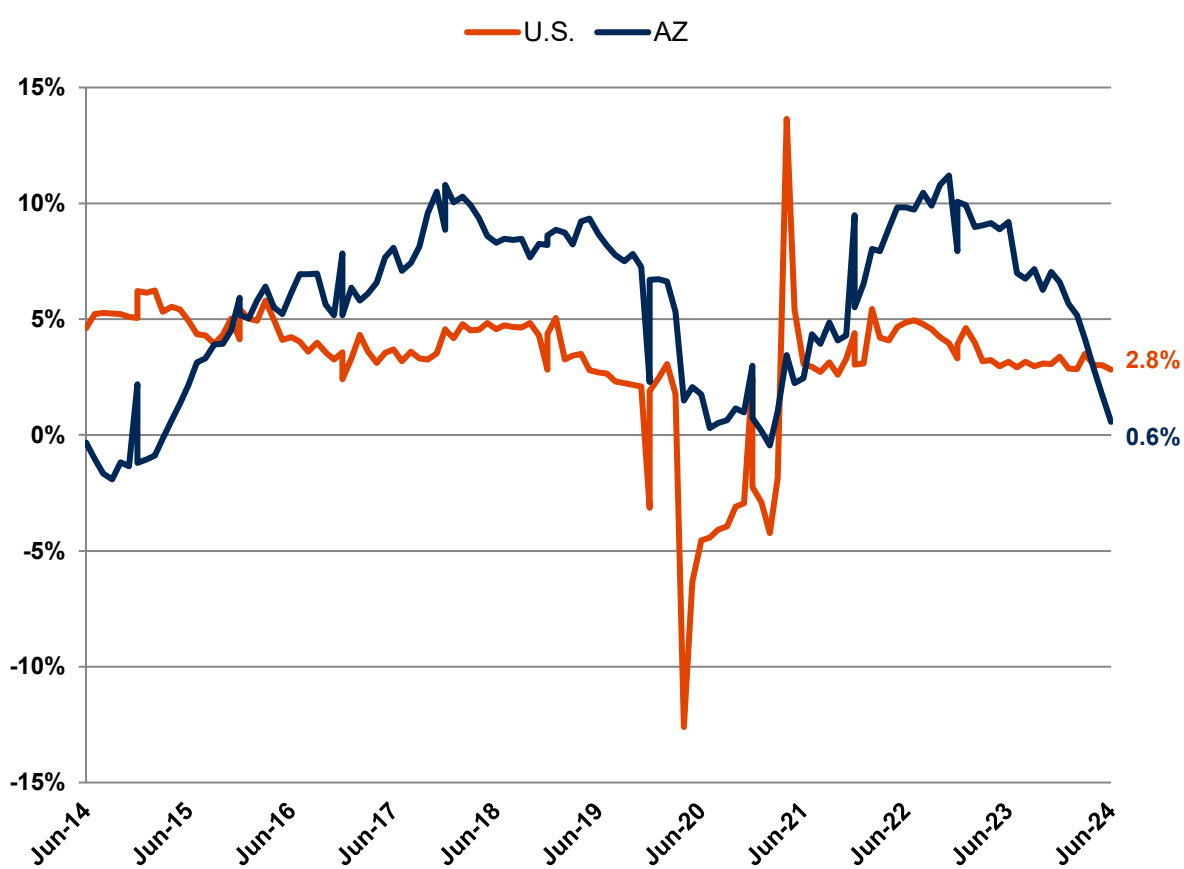
Arizona & U.S. Unemployment Rate
Seasonally Adjusted



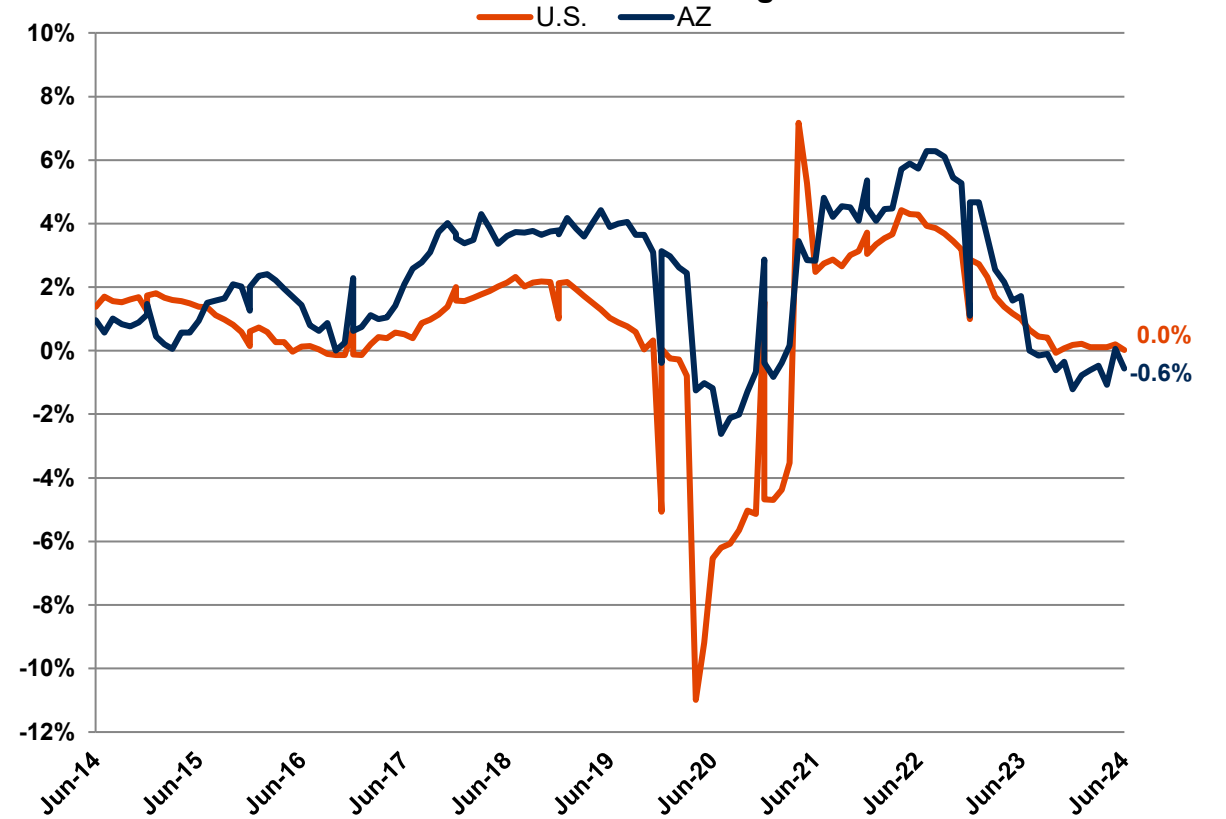
Arizona & U.S. Nonfarm Employment

Year-to-Year Percent Change



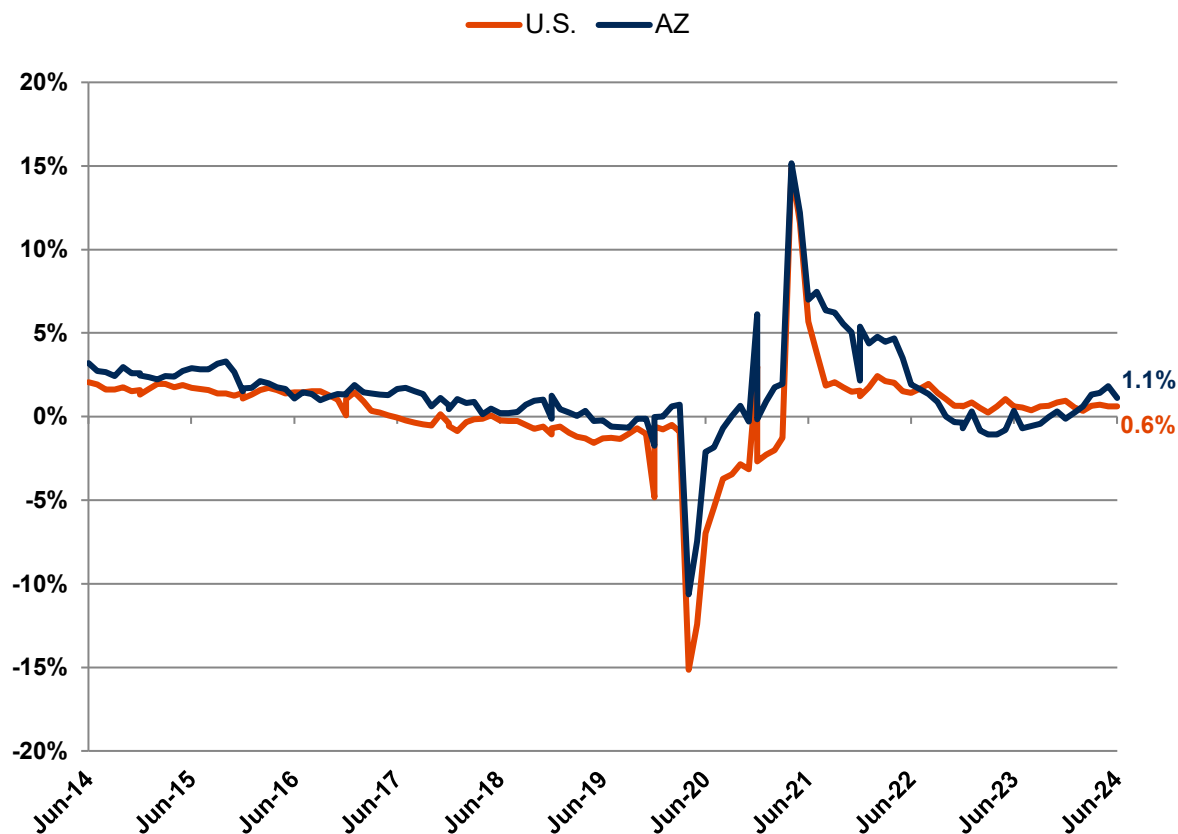
Arizona & U.S. Manufacturing Employment
Year-to-Year Percent Change



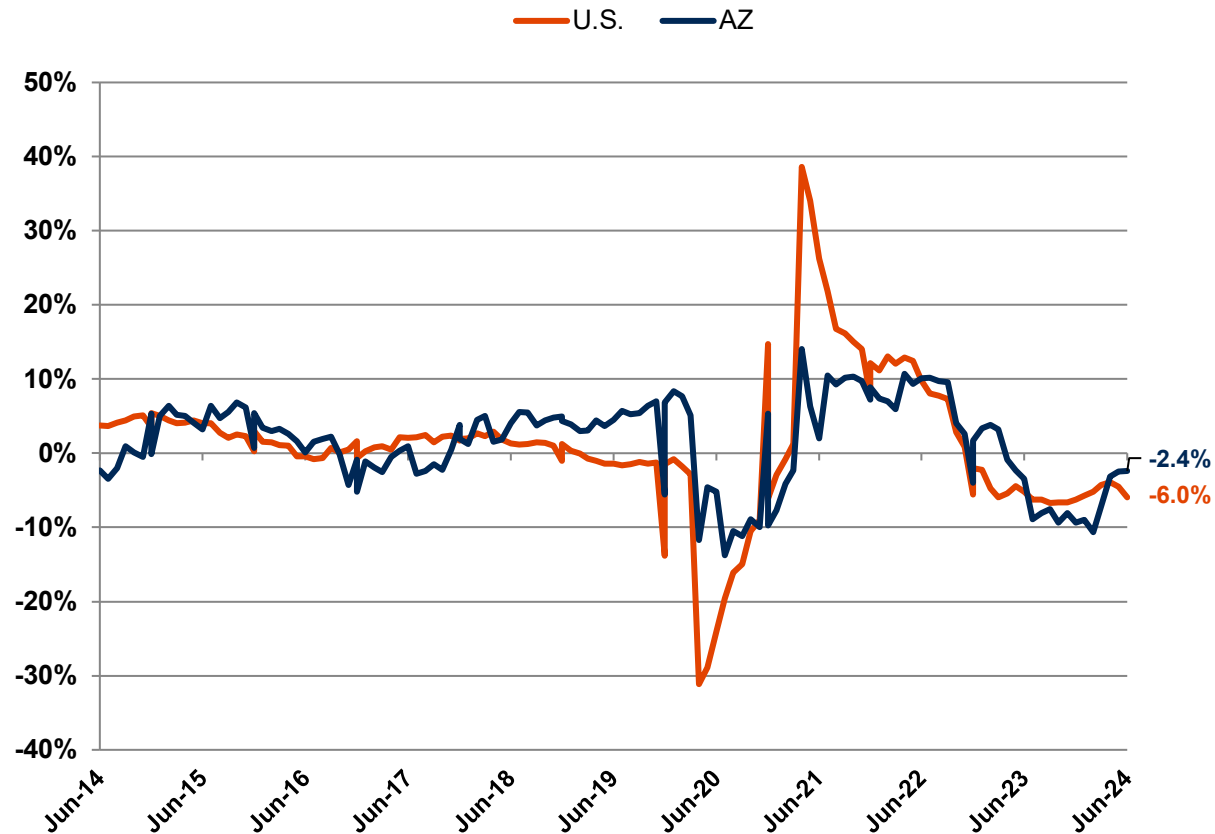

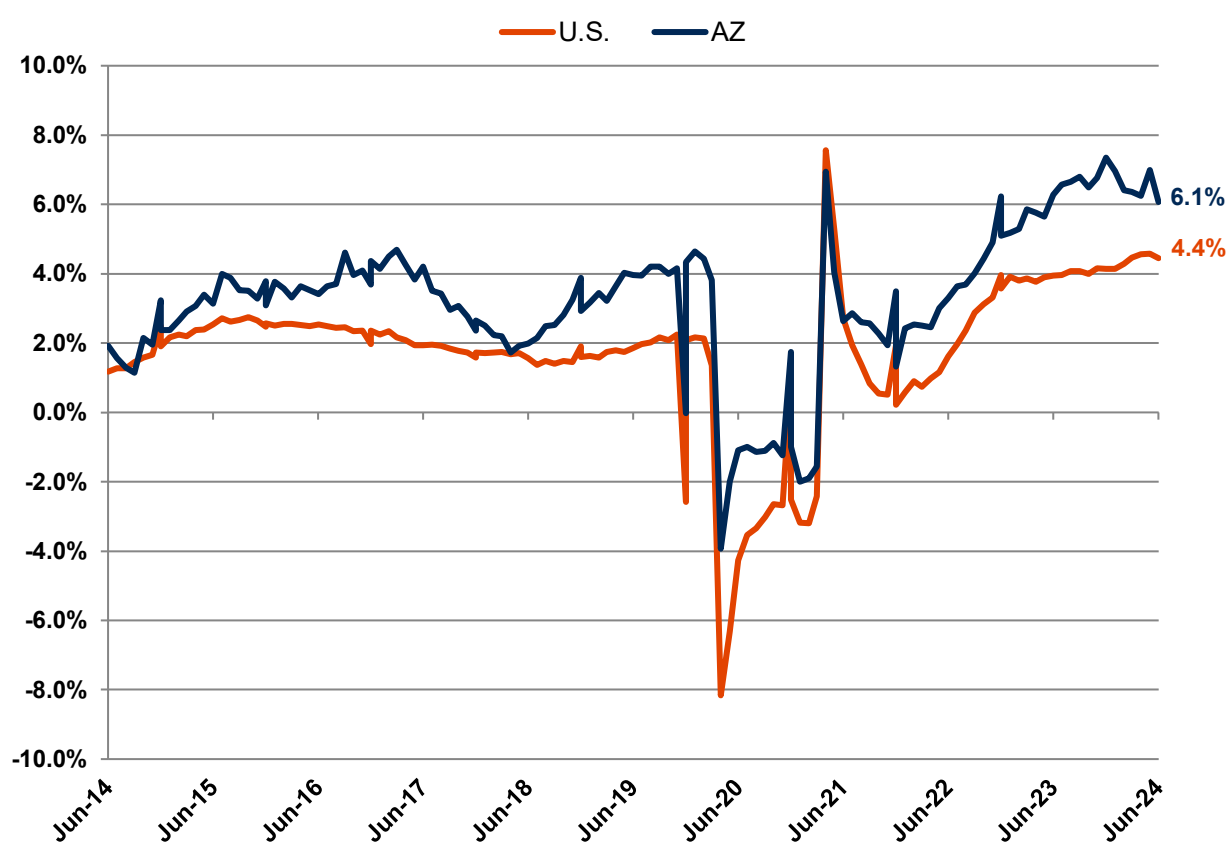
Arizona & U.S. Retail Trade
Year-to-Year Percent Change



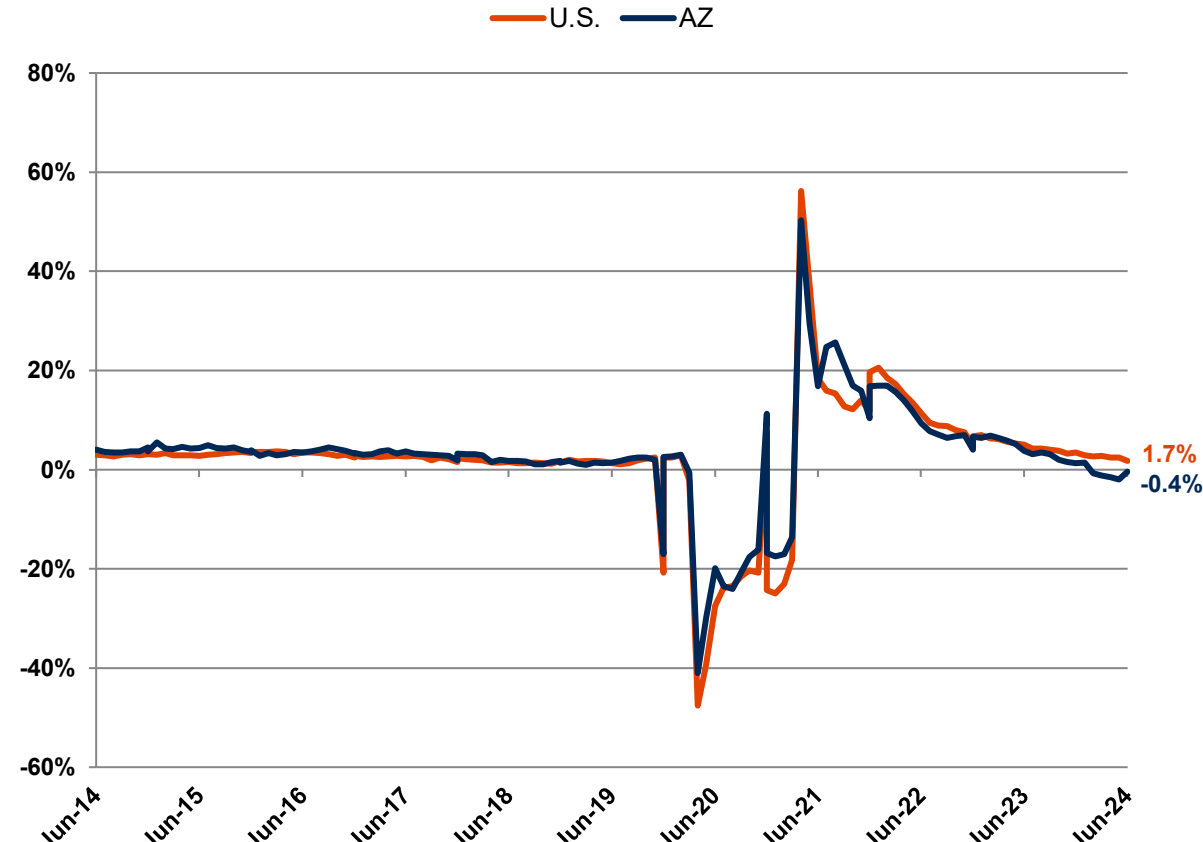
Arizona & U.S. Employment Services
