Arizona Employment Increased by 65,900 Jobs Since September 2023 Arizona Unemployment Increased to 3.5%

The Arizona seasonally adjusted (SA) unemployment rate increased to 3.5% in September 2024 from 3.4% in August 2024. The U.S. SA unemployment rate decreased to 4.1% in September 2024 from 4.2% in August 2024.

Month over month, Arizona's SA labor force decreased by 616 individuals, or 0.0%. Year over year, the SA labor force increased by 44,471 individuals, or 1.2%.

Month over month, Arizona not-seasonally adjusted (NSA) total nonfarm employment increased by 29,300 jobs. Year over year, NSA total nonfarm employment increased by 65,900 jobs, or 2.1%. Arizona SA total nonfarm employment increased by 11,200 individuals, or 0.3%, month over month.

Month Over Month

Arizona NSA nonfarm employment increased by 29,300 jobs in September. Prior to the pandemic (2010-2019), NSA nonfarm employment gained 28,800 jobs on average in September. The private sector recorded a gain of 8,900 jobs in September, led by gains in Private Educational Services (4,000 jobs) and Health Care and Social Assistance (3,300 jobs). Prior to the pandemic (2010-2019), private sector employment averaged a gain of 5,500 jobs in September. The government sector recorded a gain of 20,400 jobs in September, less than the pre-pandemic (2010-2019) average gain of 23,300 jobs. Employment gains in the government sector occurred primarily within State Government (11,300 jobs), which is typical this time of year as local and state education hiring increases as schools begin their new years.

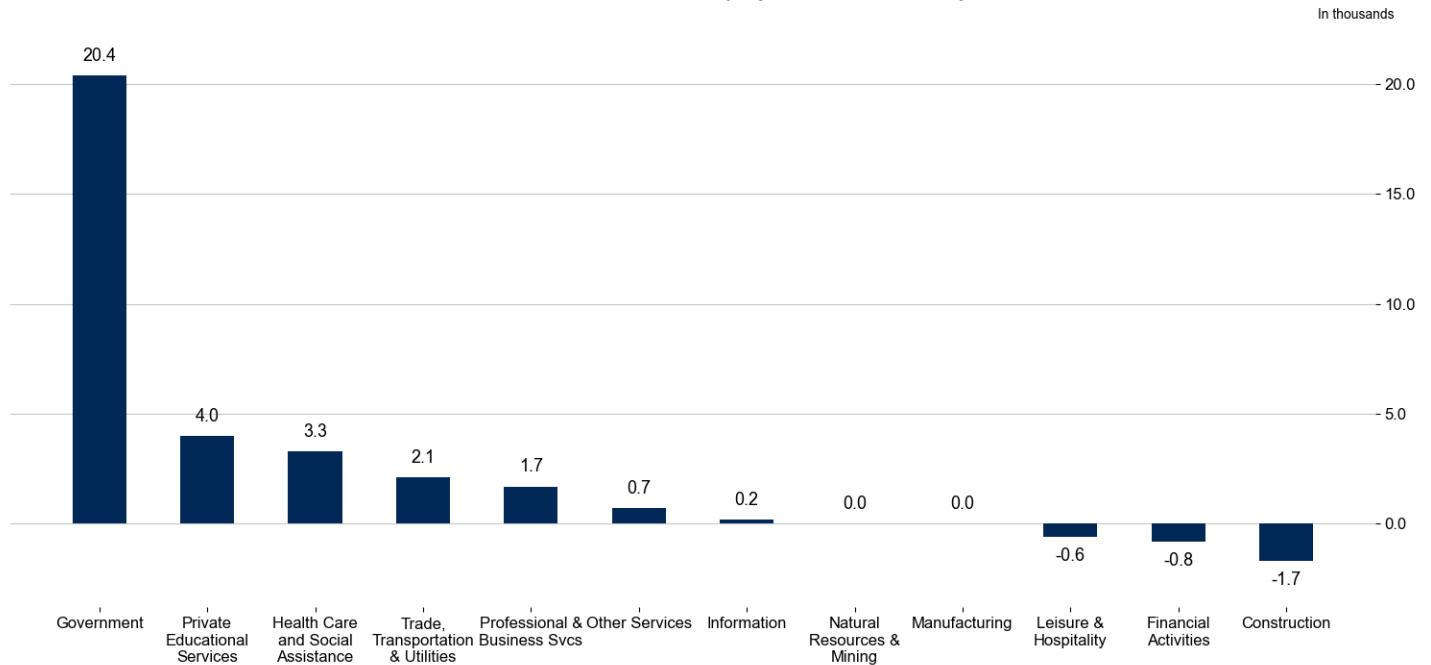

Year Over Year

Arizona NSA nonfarm employment increased by 65,900 jobs or 2.1% in September year over year. Private sector employment increased by 57,900 jobs year over year, while government employment increased by 8,000 jobs year over year.

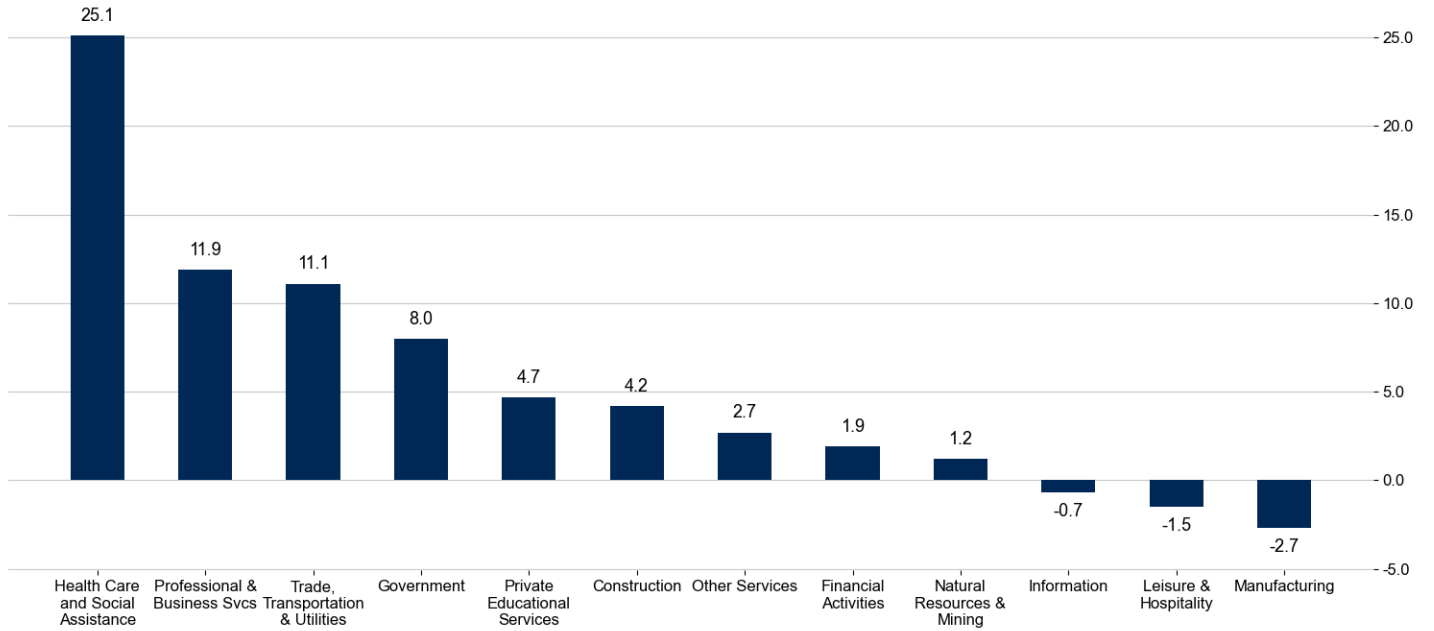

Arizona NSA Year-Over-Year Employment Gain/Loss by Sector

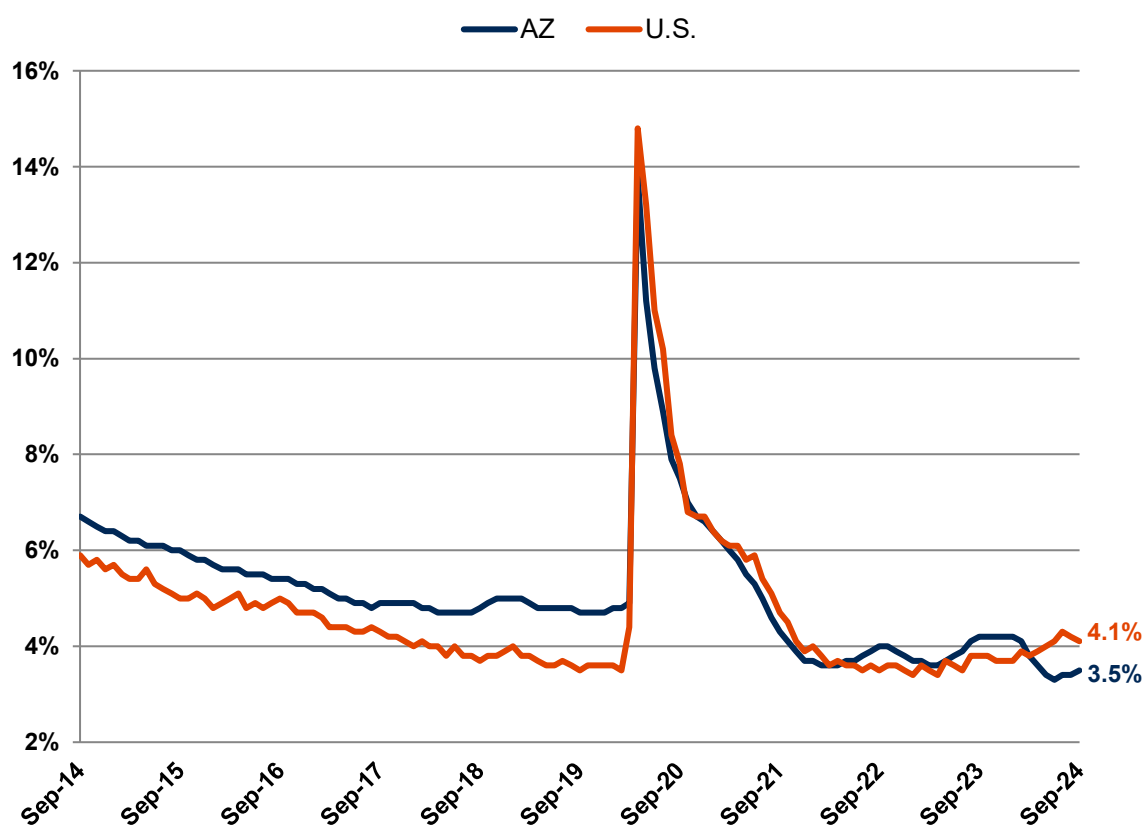

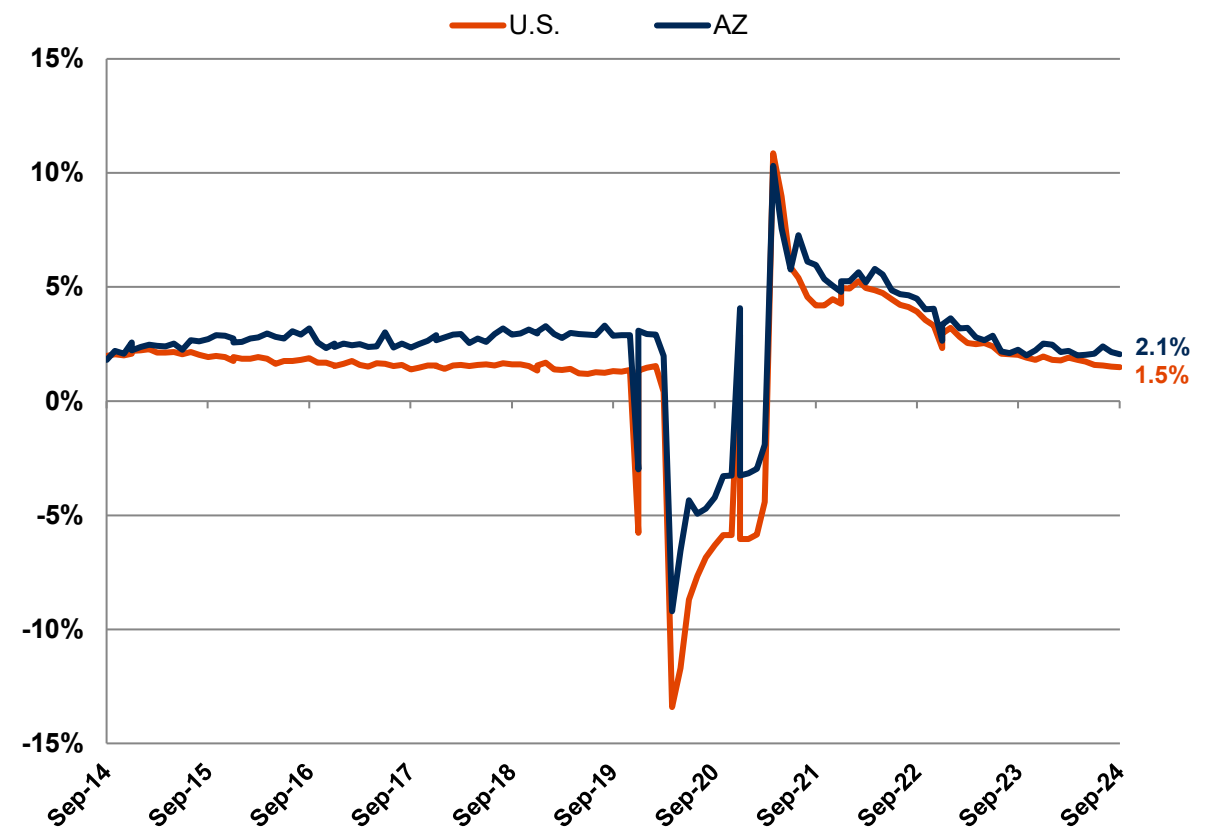

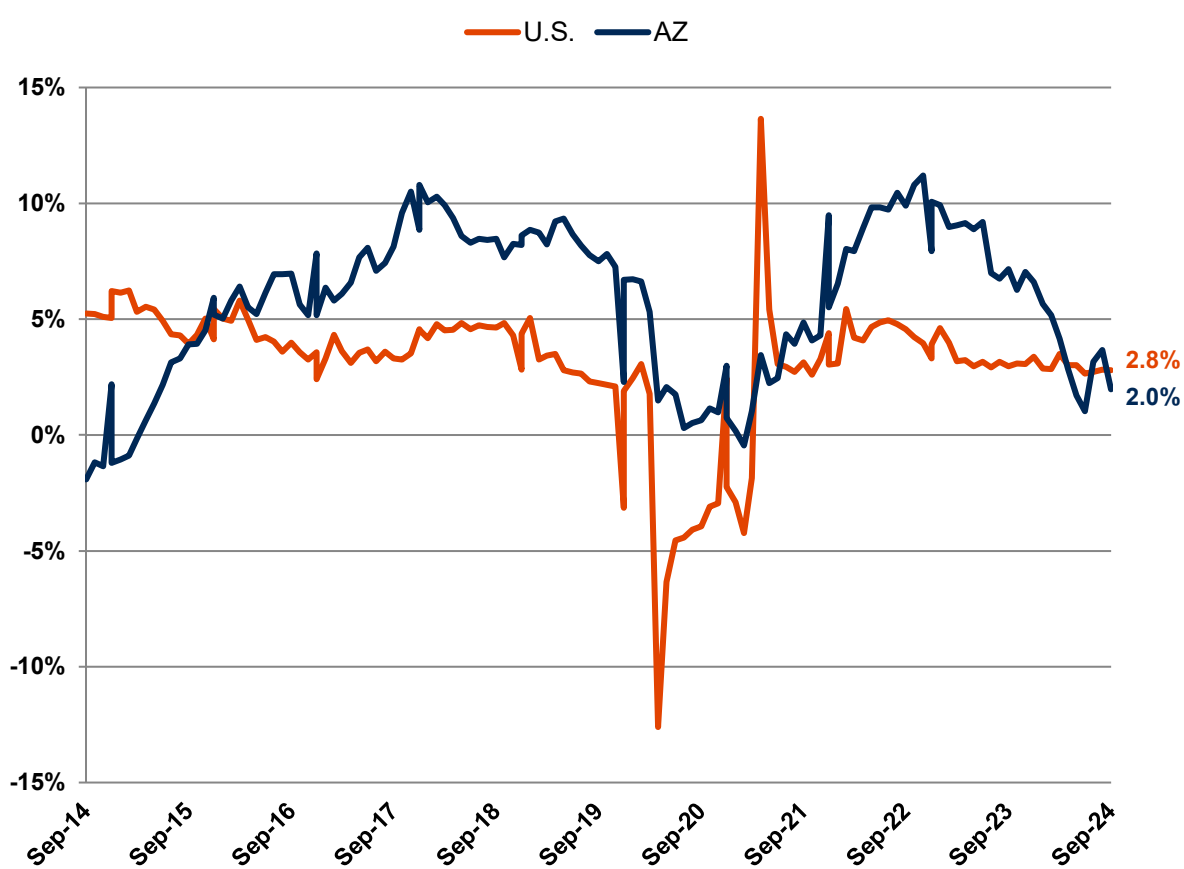
Arizona & U.S. Unemployment Rate
Seasonally Adjusted



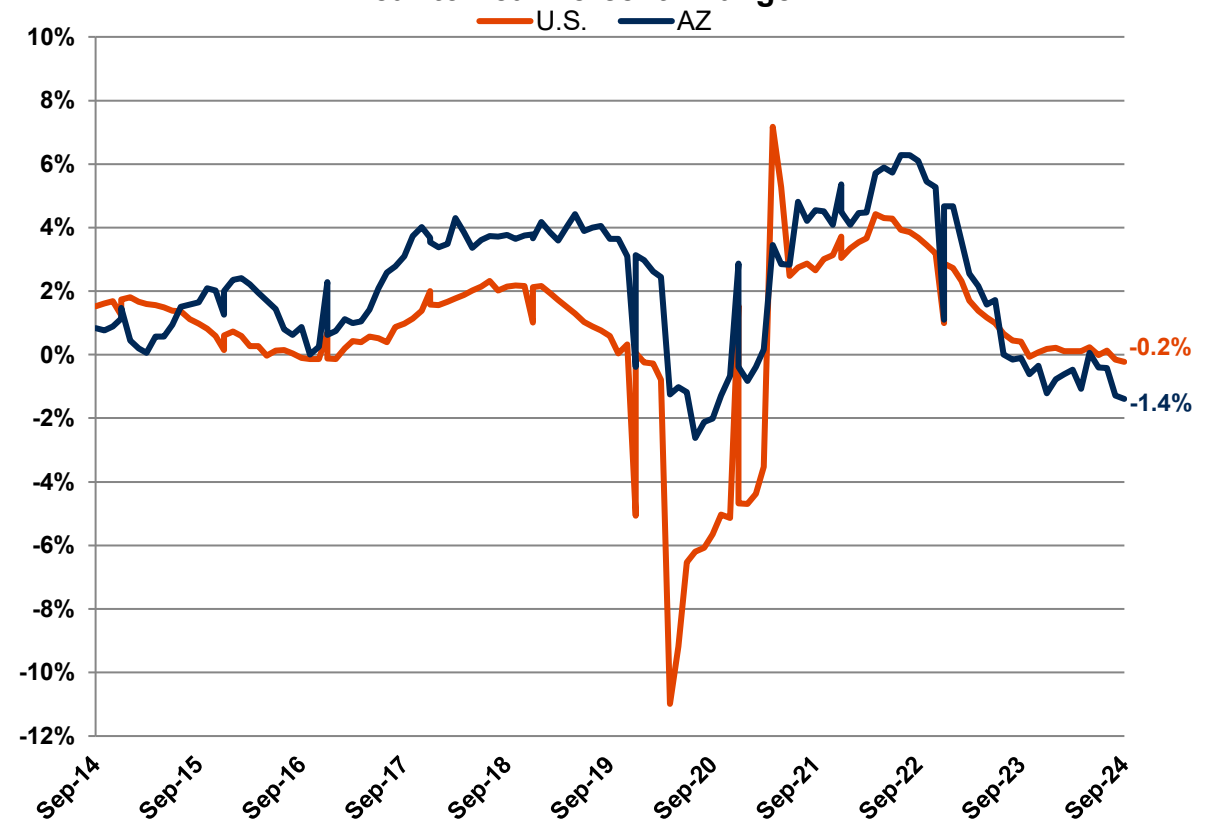
Arizona & U.S. Nonfarm Employment

Year-to-Year Percent Change



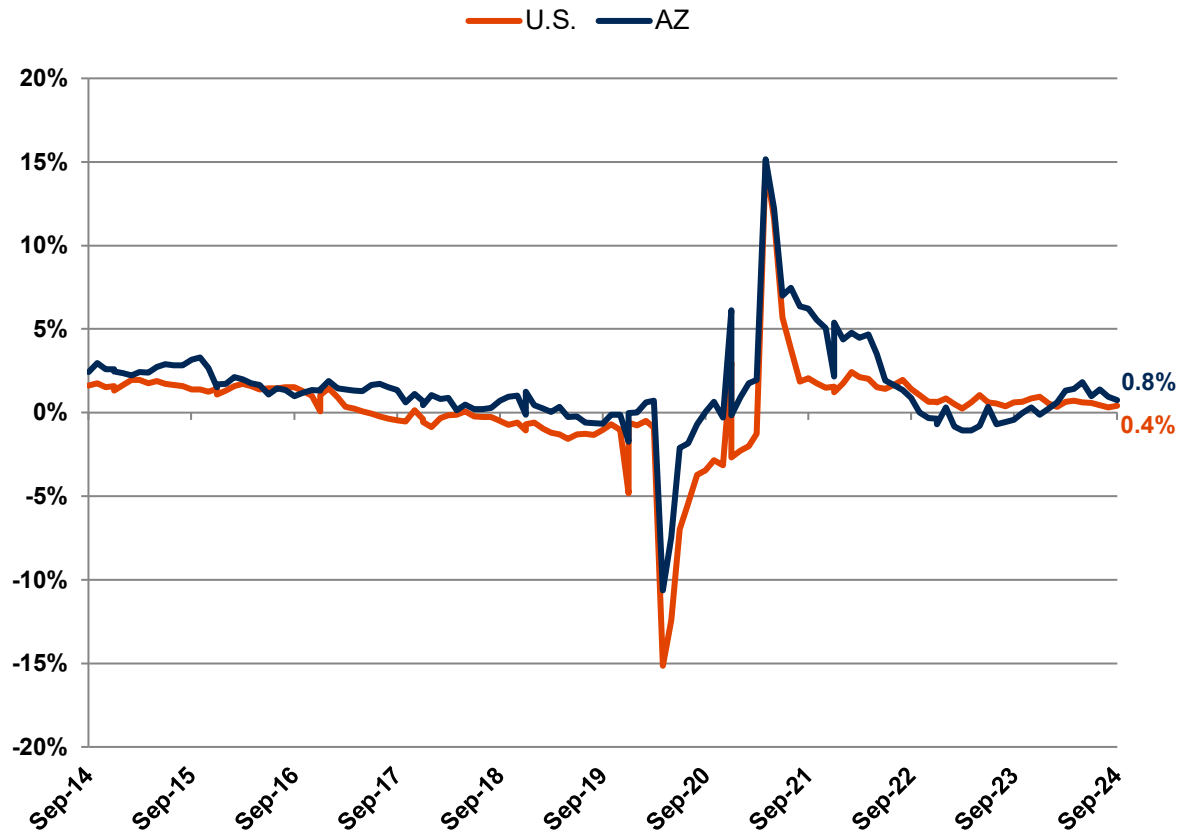
Arizona & U.S. Manufacturing Employment
Year-to-Year Percent Change



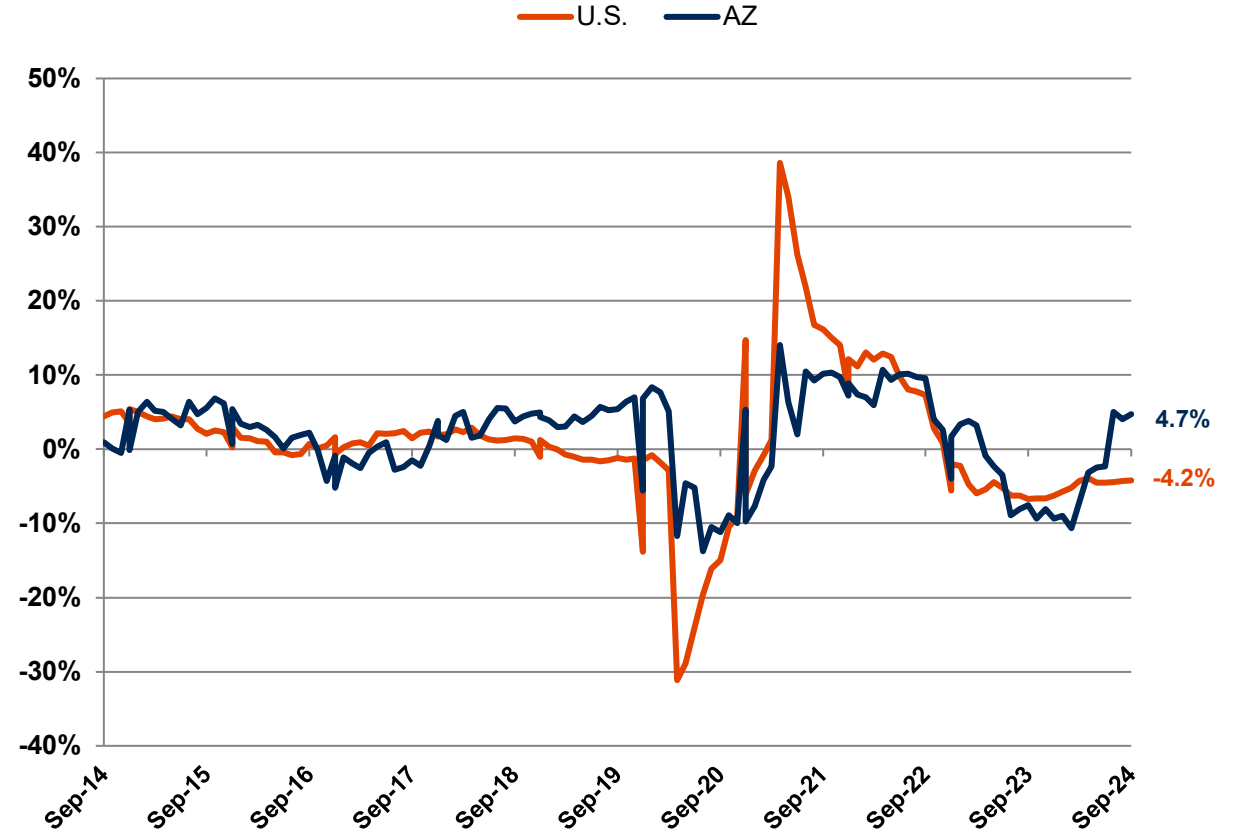

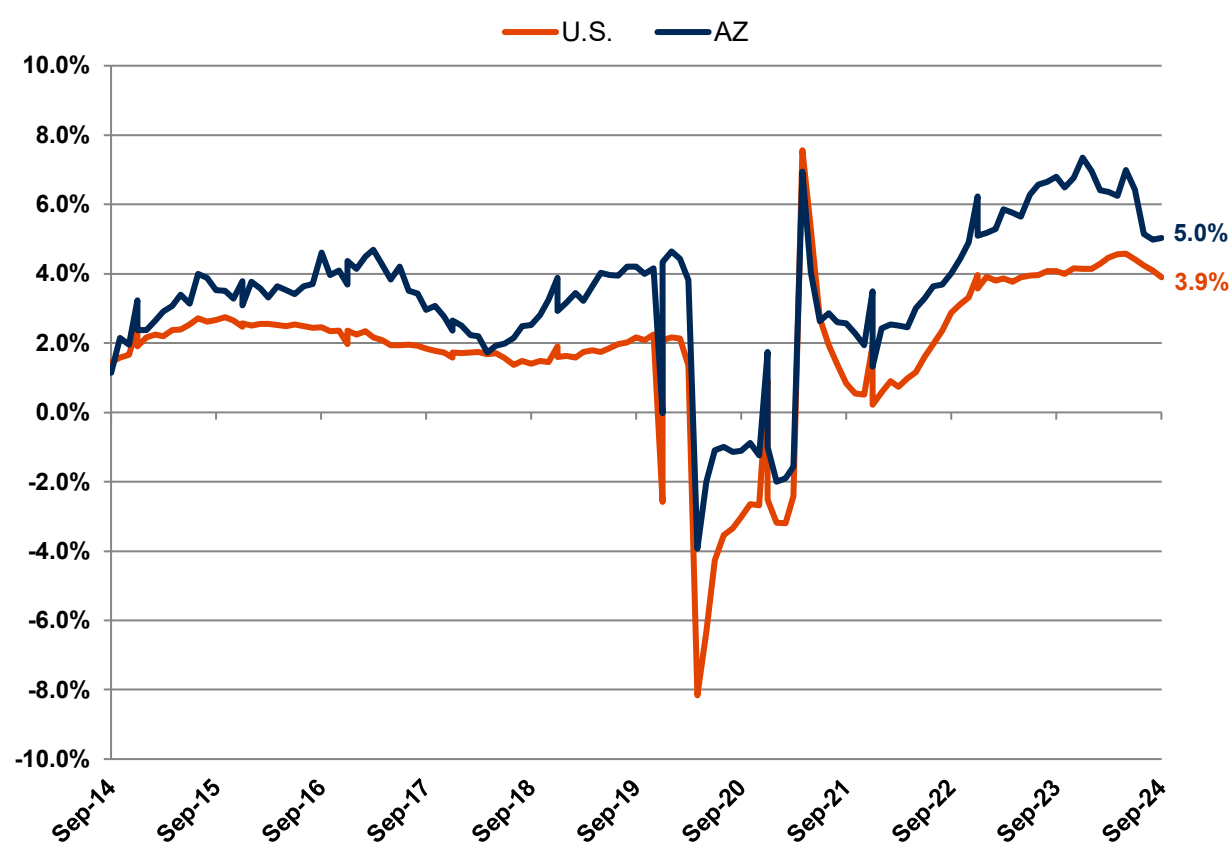
Arizona & U.S. Retail Trade
Year-to-Year Percent Change



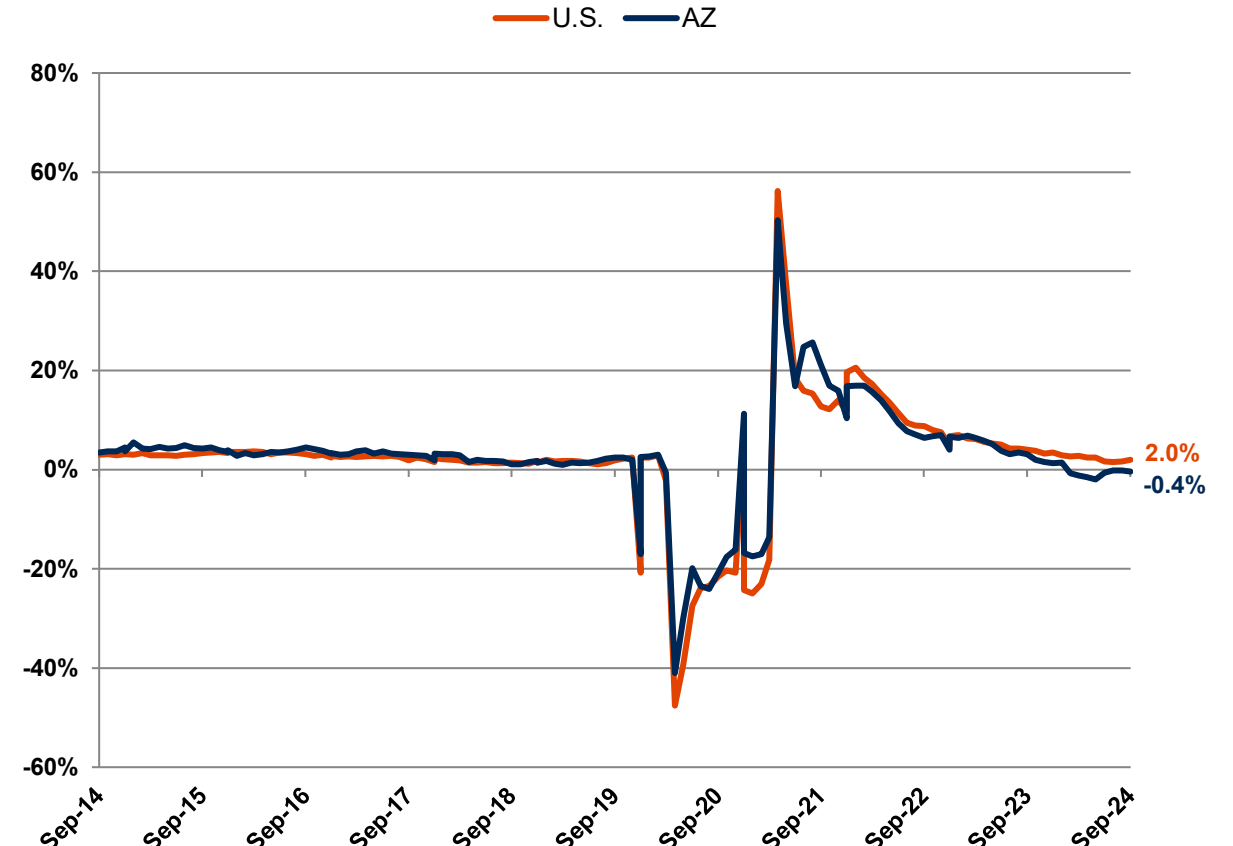
Arizona & U.S. Employment Services
